### 2:00 – 2:40 Using Technology to Support the Transition to a Skills-Centered Labor Market

Luis Gonzalez of Technologico de Monterrey, the largest private university in Mexico, will present his team's "ShapingSkills" research project, which enhances the extraction of skills from documents such as job postings. Mike Sanders of George Washington University will present an overview of the LAISER project, which applies AI large language models to overcome some of the inherent barriers in how educational institutions and labor markets communicate credential information to each other. Both projects aim to facilitate the transferability of skills within and across education systems and labor markets and complement an emerging career navigation and upskilling technology ecosystem.
