

Introduction

Vice Chancellor for Research, Alexander Gates



In his introductory address to the Rutgers-Newark community last year, Interim Chancellor Yeagle challenged the campus to double the amount of external funding over the subsequent five year period. I am happy to report that in the first year, the campus more than met that challenge. In the 2012-2013 fiscal year, Rutgers-Newark set a new campus record for external funding by bringing in more than \$33 million.

This represents an increase of 22% over the 2011-2012 fiscal year amount or 2% more than the 1/5 challenged increase. Even more impressive is that this increase came in spite of the decline and end of the increased funding through the federal ARRA program as well as the hardships imposed by the federal sequestration which has severely limited federal funding opportunities. The vast majority of universities in the United States saw a decrease in external funding as a result. This makes our feat even more impressive.

Our increase was fueled by several initiatives including an impressive effort by Interim Chancellor and Dean of SCJ, Todd Clear, who brought in \$4 million through his NJ-STEP program. Brenda Hopper also had a record year for the Small Business Development Center, also bringing in more than \$4 million. There were several other impressive success stories with new grants and initiatives that helped to fuel this accomplishment. I congratulate all of you who helped to bring about this success. For those who are making the effort but have yet to be successful, have faith and perseverance; your time will come.

Enough reading, everyone get back to writing your proposals; we have to reach \$39 million this year.

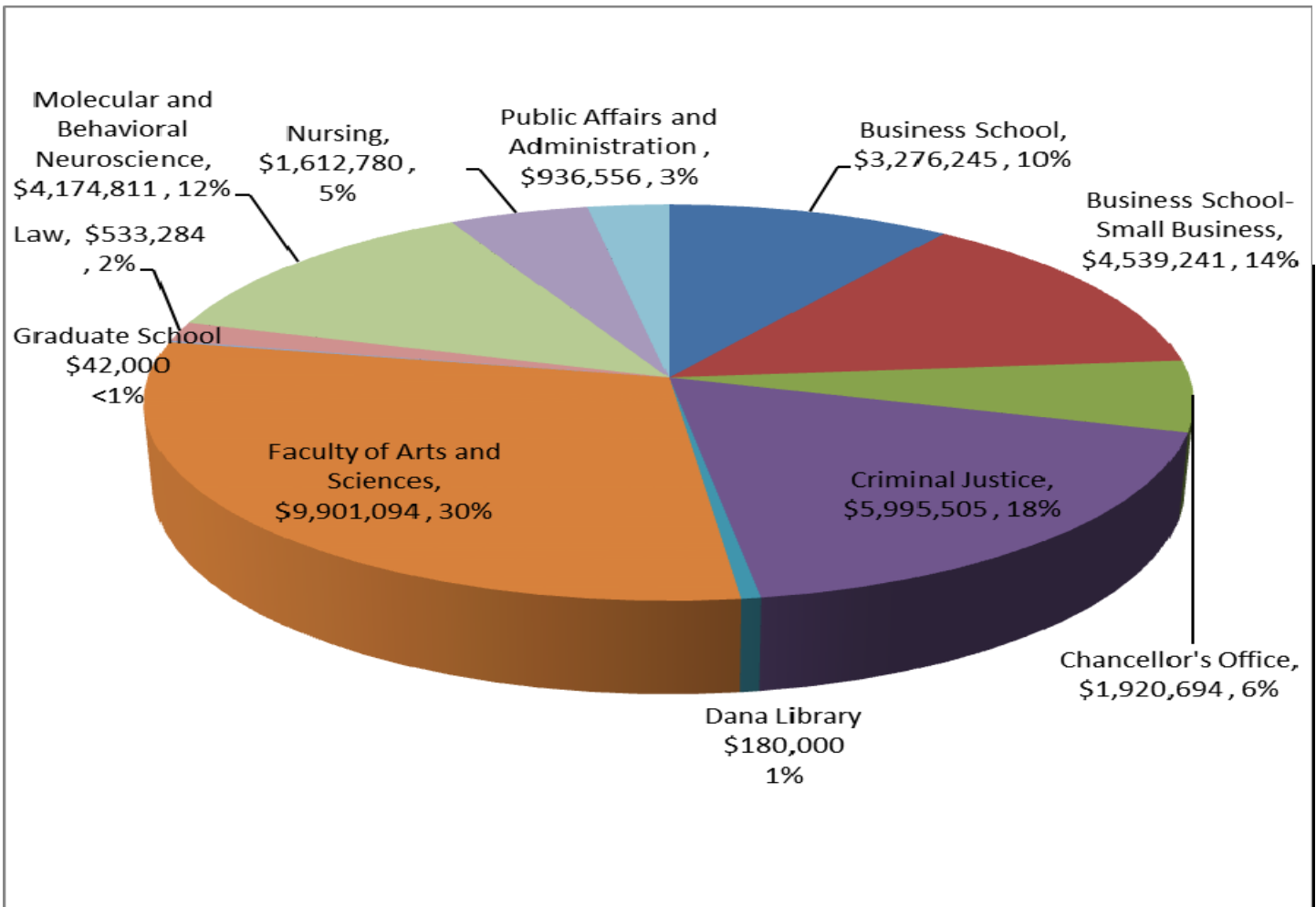

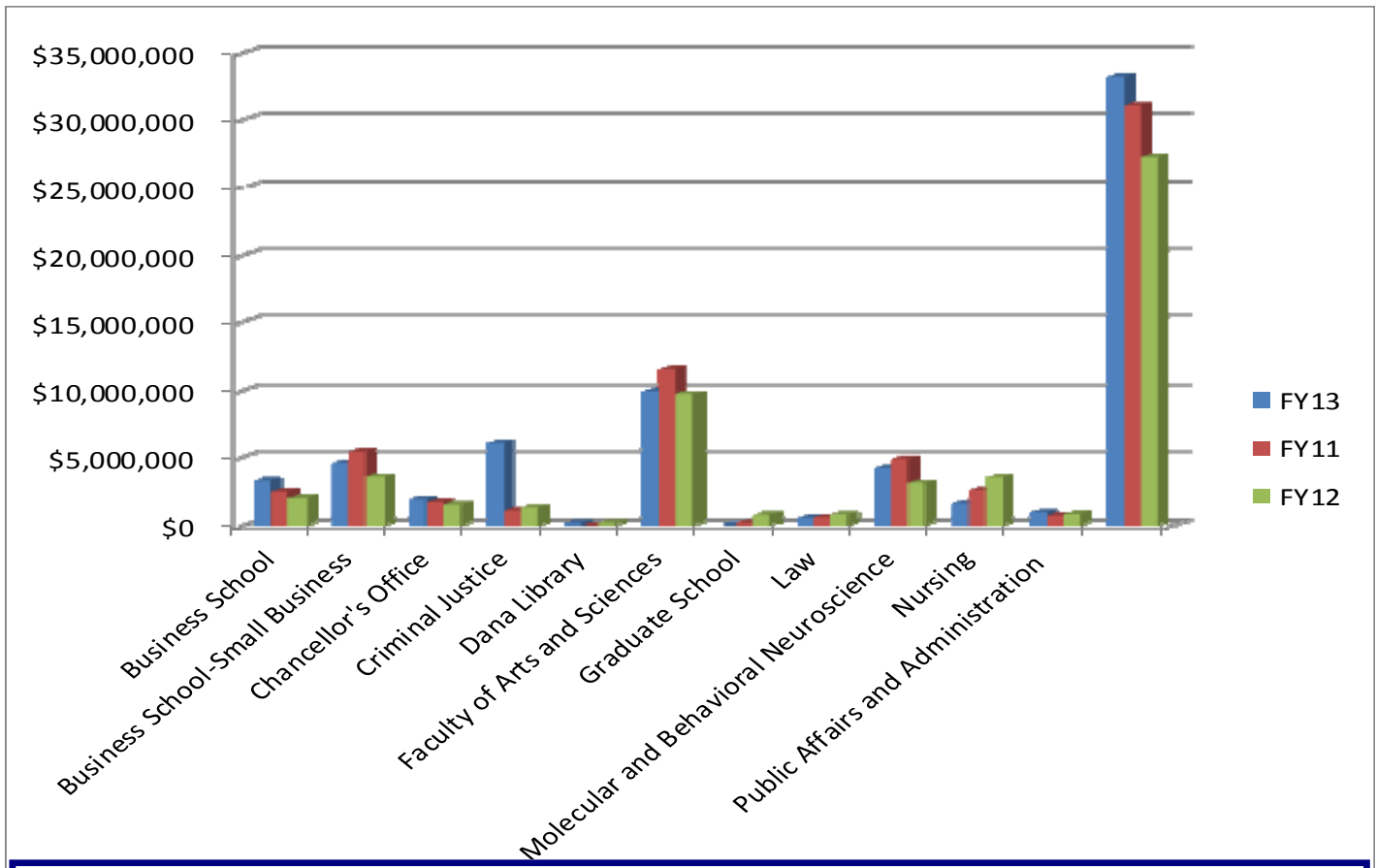

BY DEPARTMENT - FY13 / FY12 / FY11



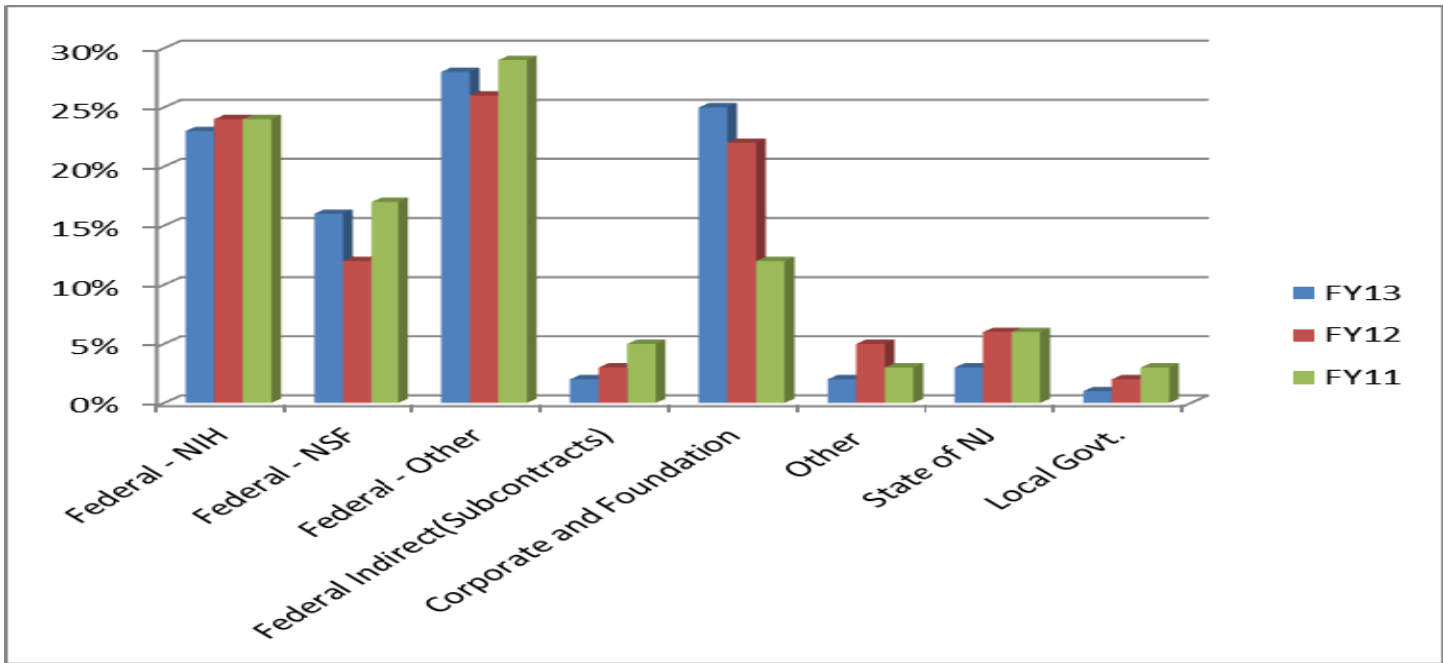
The success in FY13 is attributed to several large funding amounts of one million dollars and above.

Notable among those amounts were the two grants of two million dollars each received for the NJSTEP (New Jersey Scholarship and Transformative Education in Prisons Consortium) coordinated in the School of Criminal Justice under the leadership of Clear Todd. The consortium is charged with the stated mission *to enhance and coordinate higher educational services to all students under custody of the State of New Jersey while incarcerated and upon release.* The program is currently supported with funding from The Sunshine Lady Foundation, Inc. and The Vera Institute of Justice under its Vera’s Pathways from Prison to Postsecondary Education demonstration project which is supported by several major Foundations including Gates, Ford, Open Society and Sunshine Lady. The Consortium works in partnership with, and partial funding from the New Jersey Department of Corrections and State Parole Board. One expected outcome is the development of a national model. The current Consortium members engaged in the project with Rutgers are Drew University, Essex County College, Mercer County Community College, Princeton University, Raritan Valley Community College and The College of New Jersey.

THE STORIES AND THE PEOPLE BEHIND THE NUMBERS

The total award dollars for FY13 was \$33,112,210, based on the internal records of the Research Office. The amount reflects a 22% increase from the FY12 total of \$27,223,575.

The Small Business Development Centers in New Jersey are supported by the US Small Business Administration which is the largest single annual source of federal dollars to the campus. The Centers are managed by Brenda Hopper and her team.

This year the Center also received funding of \$1,052,600 in support of services to small businesses affected by Tropical Storm Sandy.

Federal funding accounted for 69% of total awards while corporate and foundation grants accounted for 25%.

The Psychology Department recorded the largest total award dollars within FASN at \$3,388,522, followed by Biological Sciences with \$2,646,979.

School of Criminal Justice had its most successful funding period to date with a total of \$5,995,505.

CMBN funding increased by \$1,071,840 from FY12.

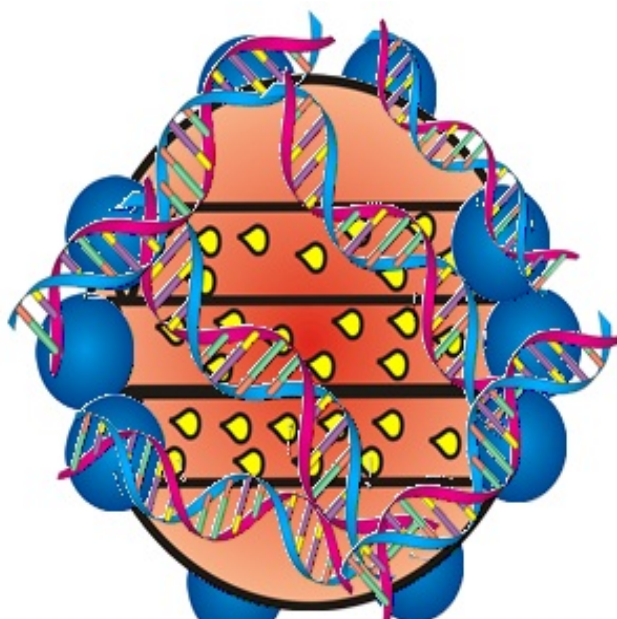
Rutgers Business School (excluding SBDC) increased its funding by \$1,284,400. This amount was bolstered by the \$1,600,000 of additional Prudential support for the Institute for Ethical Leadership.

Several Young Investigators continue to triumph with external funding for their research projects, including Nan Gao, William Graves and Vanessa LoBue.

The National Science Foundation funded Garden State LSAMP project just completed year four of its five years of funding but the program has already achieved its goal of doubling the number of graduates from underrepresented minority groups in STEM disciplines. The project is led by Alexander Gates, Vice Chancellor for Research.

Several community based projects were funded in FY13, including the federal and foundation supported Promise Neighborhood project led by Diane Hill in the Chancellor's Office. The project targets high schools in the Newark Fairmount area and uses a "collaborative leadership model ... to establish a shared vision, and goals: develop strategy; and align and focus services and solutions."

The diagram is a product of the research conducted by Huixin He and her Group in the Newark Chemistry Department. It shows how mesoporous silica nanoparticles (MSNs) are used to co-deliver doxorubicin (Dox) (as a model apoptosis-inducing anticancer drug) and a siRNA (as a suppressor of cellular antiapoptotic defense) simultaneously into multidrug resistant cancer cells for efficient cancer therapy.
